**WILDCAT EXTERMINATING, INC is not responsible for any repairs or no-cost re-treatment(s) if direct wood to earth contact, roof leaks, plumbing leaks, or other excessive moisture conditions exist in, under, or adjacent to treated structure(s). If the treated structure is modified in any way after the date of the initial treatment, this agreement is subject to termination unless prior notification is made to WILDCAT EXTERMINATING, INC and WILDCAT EXTERMINATING, INC is authorized to provide necessary additional treatment(s) and/or adjust optional service agreement renewal fee(s).**

**PLEASE NOTE: IF YOU FAIL TO PAY YOUR SERVICE AGREEMENT WILL BE VOID.**

**This service agreement shall be binding upon the heirs, executors, administrators, assignees, and successors in interest to the parties hereto. Wildcat Exterminating, Inc shall be excused from performance because of strikes, wars, or acts of God. At the companies' option, a renewal notification will be given at the end of the original agreement period.**
